## 2012 holiday calendar and early closing dates for European markets

- **Wednesday 26 December 2012 (Boxing Day)**

On Monday 24 December and Monday 31 December 2012, trading on the cash markets will close at 14:00 CET.

As some other markets have not yet published their trading schedules for next year, more detailed information on the calendars for NYSE Arca Europe and SmartPool Trading Limited will be published in due course.
